Investable Balance Calculation

1. Earnings Credit Rate - Rate applied to Investable Balance is average Fed Funds rate for the month less 1/4% (a higher rate may temporarily be set)

2. Reserve Requirement - 10% (may be temporarily suspended based on Federal Reserve Policy)

3. Uncollected Funds Rate: Rate applied to average negative collected balance is 18% APR

NOW Business Checking – monthly interest paid will be a charge to the analysis calculation

FDIC Insurance Coverage – pass through insurance subject to change based on FDIC assessment. Currently \$.125 per \$1,000 monthly average ledger balance.
